## STANDARD COLLECTION NOTICE

This Collection Notice explains in general terms how we protect the privacy of the personal information provided when a child is enrolled at the College. In reviewing this Collection Notice and providing us with your personal information, you consent to our collection, use and disclosure of that information in the manner set out below, unless you tell us otherwise:

- a) The College collects personal information, including sensitive information about students and parents/carers and family members before and during the course of a student's enrolment at the College. This may be in writing or in the course of conversations. The primary purpose of collecting this information is to enable the College to meet its educational, administrative and duty of care responsibilities to its students and to enable them to take part in all activities offered by the College.
- b) Some of the information the College collects is to meet the College's legal obligations, particularly to enable the College to discharge its duty of care.
- c) Laws governing or relating to the operation of the College require certain information to be collected and disclosed. These include relevant Education Acts, Public Health and Child Protection laws.
- d) The College may request medical reports and health information about students from time to time to discharge its legal duty of care to the student and to other students and staff. This includes a student's asthma and anaphylaxis action plans, as well as any other health or medical information which is reasonably likely to impact on the College's ability to provide educational, first aid and related services.
- e) A student's health and medical information will be disseminated and used within the College to best meet the College's duty of care responsibilities. This may include the use of photographs with health action plans to facilitate the identification of students who may be at heightened risk. Health information about students is sensitive information within the terms of the Australian Privacy Principles (APPs) under the Privacy Act 1988.
- f) The College may disclose personal and sensitive information for administrative, educational and support purposes (or may permit the information to be directly collected by third parties). This may include to:
  - o government departments;
  - o third party service providers that provide online educational and assessment support services or applications (apps), which may include email and instant messaging;
  - o another College to facilitate the transfer of a student;
  - o medical practitioners, and people engaged by the College to provide educational support and health services, including specialist visiting teachers, sports coaches, volunteers, counsellors and providers of learning and assessment tools;
  - o assessment and educational authorities, including the Australian Curriculum, Assessment and Reporting Authority;
  - o people providing administrative and financial services to the College;
  - o anyone you authorise the College to disclose information to; and
  - o anyone to whom the College is required or authorised to disclose the information to by law, including under child protection laws.
- g) If this information is not provided to us, the College will not be able to fully discharge its duty of care to its students and staff.
- h) The College will engage in fundraising activities from time to time. Information received from you may be used for these purposes. We will not disclose your personal information to third parties for their own marketing purposes without your consent.

- i) The College may also use cloud computing service providers to store personal information (which may include sensitive information) on their servers in the 'cloud'. These servers may be located in or outside Australia. This may mean that personal information may be stored or processed outside Australia. The College's Privacy Policy contains further information about its use of cloud and other third-party service providers and any of their overseas locations.
- j) The College's Privacy Policy can be found on the College website and sets out how parents, carers or students may seek access to, and correction of their personal information which the College has collected and holds. However, access may be refused in certain circumstances such as where access would have an unreasonable impact on the privacy of others, or may result in a breach of the College's duty of care to the student, or where students have provided information in confidence. Any refusal will be notified in writing with reasons if appropriate.
- k) The College's Privacy Policy also sets out how parents, carers and students can lodge a complaint about a breach of the APPs and how the complaint will be handled.
- l) On occasions information such as academic and sporting achievements, student activities and similar news is published in the College Newsletters and magazines, on physical displays throughout the College and on our intranet. This may include photographs and videos of student activities such as sporting events, College camps and College excursions. The College will obtain necessary permissions from the student's parent or carer (and from the student if appropriate) prior to including such photographs or videos or other identifying material in its promotional material or otherwise making this material available to the public, such as on the internet.
- m) If you provide the College with the personal information of others, such as other family members, doctors or emergency contacts, we encourage you to inform them that you are disclosing such information to the College and why. They can request access to and correction of this information if they wish and can refer them to the College's Privacy Policy for further details about how such requests can be made and how the College otherwise handles the personal information it collects and complaints it receives.
